4. Vendors must check-in and set up between 10:00 a.m.–2:00 p.m. on show day. Booths must be manned at all times. Unhurd Conversations, LLC is not responsible for unmanned tables. Unmanned tables will be reassigned without notice. Vendors are required to stay during the entire show and clean up after themselves.

5. Vendor assumes full liability and risk and holds Unhurd Conversations, LLC, and its affiliates harmless against any loss or damage, including property damage or guest injury, as a result of this show.
