1. The number of chairs in a booth package include the number of workers in a booth. Additional guest passes (outside of what is provided in the package) may be purchased for \$25.00.
2. Payment for all items selected on the application must be received in full by **October 13, 2023**.

Tables are non-transferable to other people or other shows and may only be used by the Vendor specified in this contract. All displays must be complementary to the show and must be confined within the booth space purchased. No loud speakers or amplifiers or loud music is permitted.
3. Unhurd Conversations, LLC reserves the right to refuse applications that are not complementary to the Naturally Hurd Hair Event.
4. Vendors must check-in and set up assigned vendor space between 11:00 p.m.-2:00 p.m. on show day. Booths/tables must be manned at all times during the show. Unhurd Conversations, LLC is not responsible for unmanned tables. Unmanned tables will be reassigned without notice. Vendors are required to stay during the entire show. Vendors are expected to remove all materials and trash at their assigned booth at the end of the show.
5. Vendor assumes full liability and risk and holds Unhurd Conversations, LLC, any affiliates harmless against and from any loss or damage as a result of this show, including damage to personal property or guest injury.
6. Vendor further grants full permission perpetual and worldwide to Unhurd Conversations, LLC to use all names, photographs, videotapes or quotations in accounts and promotions in any medium.
